# WEBSITE PRIVACY POLICY

## THE DPA & GDPR MAY 2018

#### WEBSITE VISITOR TRACKING

When someone visits our site we use a third party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone.
